Re: **Filing of Appeal on Dismissal of class action certification motion**

Further to immediate report of January 23, 2020 (Ref. No.: 2020-01-008044), and to the stated in Note 26C1.1.1 D to the Bank's financial statements as of December 31, 2023 (Ref. No. 2024-01-027747), and further to the immediate report of March 31, 2024 (Ref. No. 2024-01-030460), the Bank is pleased to report the following:

On June 4, 2024 the applicant filed an appeal to the Supreme Court on the ruling of the Center – Lod District Court of March 29, 2024, which dismissed the class action certification motion that was filed on January 21, 2020, against the Bank and against other banks regarding charging fees and commissions for transactions to purchase products and/or services overseas, according to Chapter 7 of the price list (titled “Foreign Trade”), rather than in accordance with Chapter 5 of the price list (titled “Foreign Currency”).
