Re: **Dismissal of an Appeal Filed Against a Judgement that Dismissed a Motion for Approval of a Class Action**

Bank Leumi le-Israel B.M. (hereafter – the “**Bank**”) hereby reports as follows:

On October 20, 2022, the Supreme Court dismissed an appeal that was filed against a court judgement that dismissed a motion for approval of a class action; at part of the motion, it was claimed that the Bank and four other banks discriminate students on the basis of the students’ age, by setting an age limit for joining a student account that provides dedicated benefits to students. The above dismissal of the appeal concluded the litigation process [for details about the process see: Note 26.C.2.1.d. to the Bank’s financial statements as of December 31, 2021 (Ref. No.: 2022-01-027658)].
