Today, 22 July, 2019, approval was received regarding the Supervisor of Banks non-objection to the appointment as aforesaid (for further details, see immediate report dated 22 July, 2019, reference no.: 2019-01-075631).

- 2. On 22 July, 2009, the term of office of Mr. David Brodet ended as the Bank's Chairman of the Board of Directors (for further details, see Immediate Report dated 22 July, 2019, reference no: 2019-01-075193).
- 3. On 22 July, 2009, the term of office of Mr. Yoav Nardi ended as a Director of the Bank (for further details, see Immediate Report dated 22 July, 2019, reference no: 2019-01-075202).
- 4. On 18 July, 2019 the Bank's General Meeting decided to appoint Ms. Irit Shlomi as a director in the status of "other director" (a director who is not an external director as stated in section 11D (a) (2) of the Banking Ordinance, 1941, for a period of 3 years, subject to the approval or non-objection by the Supervisor of Banks, As of the date of receipt of such approval or absence of opposition, and not prior to 6 September, 2019 (the date of the termination of Ms. Esther Levanon's term as a director of the Bank) (for additional details see immediate report dated 18 July, 2019, reference no: 2019-01-074368) As at the date of this report, the approval of the Supervisor of Banks has not yet been received.
