On August 28, 2023, the Bank received notice as to non-objection of the Banking Supervision Department to the appointment of Adv. Deutsch Esther, provided that two months will pass since the end of its tenures as a director in another banking group, as the Chairwoman of the Board of Directors of Cal Credit Cards Israel Ltd., and Mercantile Discount Bank Ltd. According to the above, and in accordance with the Banking Supervision Department's approval for the commencement of the term in office of the candidates that were selected for the first time in the General Meeting on their appointment's approval date, and in accordance with Section 11A to the Banking Ordinance, unless other conditions were set in the approval of their appointment, Adv. Deutsch will commence her first term in office on September 17, 2023.
