Re: **Dismissal of an Appeal Against a Judgement Rejecting a Motion to Approve a Class Action Lawsuit**

Bank Leumi le-Israel B.M. (hereinafter - the "**Bank**") hereby reports as follows:

As described in Note 26.C. 1.2 b. to the Bank's financial statements as of December 31, 2021, which were published on March 9, 2022 (Ref. No. 2022-01-027658), and as described in an immediate report dated April 30, 2015 (Ref. No. 2015-01-009684), on April 29, 2015, a motion for approval of a lawsuit as a class action was filed against the Bank. As described in the said note and in an immediate report dated February 14, 2021 (Ref. No. 2021-01-018073), on February 11, 2021, a judgment was handed down by the District Court rejecting the motion for approval of the lawsuit. As described in the said note and in an immediate report of April 19, 2021 (Ref. No. 2021-01-066114), on April 12, 2021, the applicants filed an appeal against the judgment with the Supreme Court.

On August 1, 2022, the Supreme Court dismissed the appeal, thereby concluding the legal proceedings.
