

Re: Approval of a settlement agreement in a motion for class action certification

Bank Leumi le-Israel Ltd. (hereinafter – the "Bank") hereby reports as follows:

- 1. In an immediate report published by the Bank on December 14, 2020 (Ref. No.: 2020-01-083122) and in Note 26.C.1.1.i to the Bank's financial statements as of December 31, 2022, which were published on March 14, 2023, the Bank provided information regarding a motion for class action certification that was filed against the Bank and against six other banks on November 24, 2020. According to the lawsuit, the banks have violated the Credit Information Service Law, 2016 and the regulations promulgated thereunder, claiming that the banks reported to the Central Credit Register legal proceedings against customers, contrary to the provisions of the law and in a manner that damaged the customers' ability to obtain credit and compromised their privacy and reputation. The plaintiffs do not state an assessment for the class and claim a monetary damage that varies among class members, as well as non-monetary damage.
- 2. On March 23, 2023, the Court approved a settlement agreement in this legal proceeding, which brought the lawsuit to conclusion.
