Further to immediate report of January 23, 2020 (Ref. No.: 2020-01-008044), and to what is stated in Note 26C1.1.1 D to the Bank's financial statements as of December 31, 2023 (Ref. No. 2024-01-027747), the Bank is pleased to report the following:

On March 29, 2024, the Center – Lod District Court dismissed the class action certification motion that was filed on January 21, 2020, against the Bank and against other banks regarding charging fees and commissions for transactions to purchase products and/or services overseas, according to Chapter 7 of the price list (titled “Foreign Trade”), rather than in accordance with Chapter 5 of the price list (titled “Foreign Currency”).
