For additional details see the Immediate Report dated 27 August 2015 (Reference No. 2015-01-106305). Ms. Gottlieb concluded her first term of office as an ED at the Bank. For details see the Immediate Report dated 26 August 2018 (Reference No. 2018-01-080715). On 30 April 2018, the Committee for the Appointment of Directors of Banking Corporations, appointed pursuant to 36A of the Banking Law (Licensing), 5741-1981, notified the Bank that Ms. Gottlieb was a candidate for reappointment as an ED. See the Immediate Report dated 30 April 2018 (Reference Number 2018-01-042874). On 7 October 2018, the Bank's General Meeting resolved to appoint Ms. Gottlieb as an ED at the Bank for an additional period of 3 years, subject to the approval or non-objection of the Supervisor of Banks, starting on the date of the receipt of such approval or absence of objection. For details, see the Immediate Report dated 7 October 2018 (Reference No. 2018-01-092817). On 15 October 2018, the Bank received notice of the Supervisor of Banks' non-objection to Ms. Gottlieb's appointment as an ED at the Bank, subject to the following:

- Ms. Gottlieb and/or Harvest Capital Markets Ltd. (in which Ms. Gottlieb is a 50% holder) may not provide consulting or management services to the Leumi Group, to corporate officers within the Group or to any of the Bank's substantial holders;
- (2) Ms. Gottlieb and/or Harvest Capital Markets Ltd. may not represent clients vis-à-vis Bank Leumi, corporate officers in the group, or any of the Bank's substantial holders. See the Immediate Report dated 15 October 2018, Reference No. 2018-01-096549.

Note to section 14: As of the current date, no additional memberships in the Board of Directors Committees. have yet been determined for Ms. Gottlieb. Ms. Gottlieb will

serve as a member of the Board of Directors' Committees in accordance with the Board of Directors' resolution, and will at least serve as a member of the Audit Committee, by virtue of her status as a Companies Law ED.
