4. The deposit was not used to grant a loan or as collateral for loans that the Bank has granted to my relatives<sup>2</sup> or to a legal entity of which I am a controlling owner<sup>3</sup>, if they are Israeli residents.

<sup>2</sup> "relative"—spouse, sibling, parent, grandparent, descendant, spouse's descendant, and spouse of each of the above.

<sup>3</sup> "controlling owner" – whoever holds, directly or indirectly, alone or together with a relative, one of the following:

- a) at least 10% of the issued share capital or at least 10% of the voting rights;
- b) the right to hold at least 10% of the issued share capital or at least 10% of the voting rights, or the right to purchase these;
- c) the right to receive at least 10% of profits;
- d) the right to appoint a director.
